Grower and Producer Members

For grower and producer members the fees are based on the higher of the band for hectarage of vines planted and average of the last 3 years' wine production. The table below details the fee bands.

All members must join their local geographical region (regional fees are detailed below) and may join more than one region if they wish.

For those members who produce wine, or who have wine produced for them on contract, the Annual Fee payable is the higher of their Hectarage Band and Production Band. For those members who grow grapes but who do not make wine and do not have wine made for them on contract, the fees are capped at Band 5.

Each member is entitled to a number of subscribers who may access the Members Area of the WineGB website and are enrolled in the Forum. The entitlement is determined by the fee band (capped at the band 5 level for Growers).
